

Introduction

The COVID-19 pandemic drastically affected enrollment in higher education, including the number of students who transfer institutions. The National Student Clearinghouse reports that nearly 200,000 fewer students transferred in 2021 compared with 2020 — an 8.4% decline.¹ But transfer students are a significant asset to the campus community, demonstrating commitment to academic success as well as helping institutions grow tuition revenue and meet enrollment objectives.¹¹ For this reason, recruiting and enrolling transfer students is more important now than ever before.

One challenge during the transfer pathway can be determining credit and course equivalencies. Often working in an outdated, paper-based process, staff need to manually review and enter data from multi-page, multi-format transcripts. This method is highly prone to human error, leading to frustrating rework and lost productivity for staff. And while the decision period stretches to weeks or months, students are left lacking actionable information.

Clear answers on transferable credits and course equivalency can be the deciding factor on whether a student enrolls at your institution or one of your competitors'. This ebook explores four questions transfer students ask before making their decision — and how automating transcript capture and evaluation helps deliver the answers.

HIGH RATIO OF APPLICANTS TO ADMISSIONS STAFF

Delayed admissions decisions can cause qualified applicants to look at other schools. But considering that the ratio of applicants to admissions staff is 461:1 for private institutions and 1,035:1 for public, employees are often overwhelmed with manual data entry and review.ⁱⁱⁱ

Automating transcript capture and evaluation frees up staff to focus their time on value-adding activities like making the actual decisions. Automation speeds the transcript evaluation process and slashes the decision period from weeks to days, giving your institution an edge in recruiting students.



Question 1: Do I qualify for your institution?

First and foremost, students want to know if they meet the standards to be accepted into your institution. But if your admissions staff is burdened by paper-based processes, they're spending time on manual data entry and reviewing transcripts for GPA, class rank and other factors — time that could be used in better ways.

Extracting information manually from even a simple document can take up to 20 minutes per transcript. Multiply that by thousands of students, and it's easy to see how paper-based processing leads to bottlenecks that stretch out the decision period.

Automating transcript capture and evaluation lets your staff focus on faster admission decisions, not data input. Whether transcripts come in electronically or on paper, the right solution should be able to automatically identify and capture necessary information without human intervention. Then, the information is routed to the right person for review and action.

Besides allowing your admissions department to respond to students faster, automated transcript processing also enables employees to process higher volumes without additional staff.

Question 2: Will my existing credits transfer for equivalent courses?

Course equivalency decisions are a key factor in a student's academic career, and providing answers on how their courses will fit into their chosen academic programs is critical. Manual evaluations take up unnecessary time, and worse, approaching the process on a case-bycase or ad-hoc basis runs the risk of creating errors.

An automated transcript process can accurately read and evaluate data so students are awarded the proper credit the first time. Leveraging intelligent capture, the software scans and verifies transcripts based on articulation rules for each external institution, which expedites the transfer credit evaluation process.

If a course comes through that doesn't have a pre-determined equivalency, it's flagged for review. Your staff can then define the new equivalency and add it to the database. As a result, your institution can efficiently answer students' course equivalency questions and provide faster decisions.

Manual, time-consuming transcript data entry and reviews burdened California State University, East Bay — especially during peak admissions periods. The university leveraged intelligent capture to automate the capture and evaluation of transcripts — a change that slashed processing time by 75 percent.

"Getting this information and our decisions back to students quickly is definitely a competitive advantage in securing and enrolling applicants faster," said Angela Schneider, registrar at California University, East Bay.

DELAYS IN FINANCIAL AID DECISIONS CAUSE STUDENT DISSATISFACTION AND POTENTIAL WITHDRAWAL

With six out of 10 students unsure of their application status according to the Institute for College Access & Success, it is important to facilitate faster award decisions and reduce inefficiencies.^{iv} The same study found that colleges spend over \$100,000 a year verifying student information.

An automated transcript process routes relevant information to the right people at the right time. This not only saves costs but also drives faster decision making because staff are empowered with the most up-todate information instead of bogged down searching for and verifying documents.

Question 3: Do I qualify for one of your institution's financial aid packages?

Finances will always be a large determining factor in whether a student chooses your institution over another. That's why any potential financial aid information should be provided to students as quickly as possible.

However, this is easier said than done; financial aid staff rarely have the information necessary to efficiently make award decisions. When records reside in multiple systems and formats, staff have a difficult time locating and verifying the documentation — which delays decisions and causes students to potentially withdraw.

With automated transcript and evaluation, all the relevant information (such as proof of high school completion) is automatically sent to your financial aid system. Financial aid staff have a complete view of the application with the click of a button.
